Mrs. Scheurer was respected for her commitment to others, her personal integrity and honesty and for the work she did to improve Pearce High School and this community. These scholarships will be awarded to two students who work to make a difference at Pearce High School or in their community.

This \$1,000 scholarship may be applied to 4-Year University, community college or a vocational school.

Scholarship recipients will be notified by April 12, 2021

Criteria:

- The applicant must be a graduating senior from Pearce High School.
 - The student must have participated in extra-curricular activities or worked during high school.
 - Be of good character.
 - Financial need and scholastic accomplishments will be taken into consideration.
- Scholarships will be presented at the PTA Awards and at the Senior Awards 2021.
- Funds awarded must be used within one (1) calendar year of acceptance.

- Attach a written essay of approximately 250 words or one typed page, double-spaced using a 12-point font.
